Subject: **FROM BARANGAY SALINAS 1: RESOLUTION NO. 014-2025 ENTITLED: "A RESOLUTION APPROVING AND ADOPTING THE GUIDELINES ON THE FABRICATION VERIFICATION AND MAINTENANCE OF WOODEN HEIGHT BOARDS."**
(PNOA-898-2025 dated April 21, 2025)

Barangay Salinas I has submitted *Resolution No. 014-2025*, with regard to the approval and adoption of standardized guidelines for the fabrication, verification, and maintenance of wooden height boards. These height boards are essential for various administrative and emergency purposes, such as disaster response, school requirements, and medical clearances.

FINDINGS:

The key points in implementing this resolution were:

1. The Annual weighing of all preschool children or Operation Timbang (OPT) has been expanded to include the measurement of height (for children 2 years old) or length (for children less than 2 years old) into what is now called OPT Plus.
2. The measurement of height and length would require an affordable instrument.
3. The World Health Organization has been recommended by the use of wooden height board, through clear guidelines on fabrication, calibration, verification, and maintenance.
4. To guarantee the accuracy of measurements made using wooden height boards, precise instructions for construction, calibration, verification, and upkeep must be followed.

This resolution adopting a standardized, verified, and properly maintained height boards are necessary tools for accurate, fair, and efficient public service delivery.

RECOMMENDATION:

After thorough discussion and consideration, the members of Barangay Affairs Committee unanimously recommended the **ISSUANCE OF NOTICE OF APPROVAL** to Salinas 1 Barangay Resolution No. 014-2025.

WHEREAS, the World Health Organization has been recommended by the use of wooden height board, through clear guidelines on fabrication, calibration, verification, and maintenance;


WHEREAS, there is a need to ensure the integrity of measurements using the wooden height boards, through clear guidelines on fabrication, calibration, verification, and maintenance;
