**A RESOLUTION AUTHORIZING THE HON. CITY MAYOR, STRIKE B. REVILLA TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE FEDERATION OF SPRINGVILLE CITY HOMEOWNERS ASSOCIATION, INC. (FOSCHAI) REGARDING THE IMPLEMENTATION OF THE SOLIDARITY ROUTE.**

**WHEREAS**, the vehicular traffic in the public roads within the territorial jurisdiction of the city of Bacoor were congested and necessitate innovative and drastic solutions.


**WHEREAS**, one of the solutions adopted by the City Government of Bacoor to address the traffic problem within the city is the full implementation of the Municipal Ordinance No. 21, series of 2009 entitled "An ordinance creating a traffic decongestion scheme to be known as solidarity route in the Municipality of Bacoor, Cavite" as amended by the City Ordinance No. 2013-047, series of 2013, otherwise known as "The Revised Traffic Code of the City of Bacoor".

**WHEREAS**, the successful implementation of the said ordinance require the full cooperation and support of the participating homeowners associations, one of which is the Federation of Springville City Homeowners Association, Inc. (FOSCHAI) that has agreed to be a part of the said solidarity route.

**NOW THEREFORE**, upon unanimous motion of the City Council in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to pass a resolution authorizing the Hon. City Mayor, Strike B. Revilla to sign and enter into a Memorandum of Agreement with the Federation of Springville City Homeowners Association, Inc. (FOSCHAI) regarding the implementation of the solidarity route.

**RESOLVED LASTLY**, to furnish FOSCHAI AND other government agencies concerned with copies of this resolution.
