**A RESOLUTION DIRECTING ME SICAT CONSTRUCTION INC., TO CONSIDER THE TRAFFIC SITUATION WHILE UNDERTAKING MAYNILAD'S PIPELINE CONSTRUCTION AND ROAD RESTORATION.**

**WHEREAS**, Maynilad Water Services, Inc. ("Maynilad") has ongoing pipe-laying projects in the following roads: Magdiwang Road, GSIS Road, Green Valley Road, Gardenia Road, Queens Row East Road and Queens Avenue.

**WHEREAS**, the aforementioned two-lane roads are heavily congested especially during rush hours.

**WHEREAS**, the private contractor implementing the said projects is ME SICAT Construction, Inc.

**WHEREAS**, while the City Council has no objection to the implementation of the said MAYNILAD projects to ensure constant potable water services to city residents, it is necessary to consider the inconvenience to the public brought about by the said projects.

**NOW THEREFORE**, upon motion of Councilor Bayani De Leon and unanimously seconded by the City Council, in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to pass a resolution directing ME SICAT Construction Inc., to consider the traffic situation while undertaking MAYNILAD'S pipeline construction and road restoration.

**RESOLVED FURTHER**, that the pipe-laying be completed first prior to road restoration with a maximum area of 150 meters to minimize traffic congestion.
