CITY RESOLUTION NO. CR 2016-007B

A RESOLUTION (1) RATIFYING THE "SUPPLEMENTAL CONTRACT FOR COLLECTION, HAULING AND DISPOSAL OF RESIDENTIAL WASTE" BETWEEN THE CITY OF BACOOR AND S.B. HAIN ENTERPRISES & GENERAL SERVICES AND (2) CONFIRMING THE AUTHORITY OF HON. AVELINO B. SOLIS TO SIGN THE SAME IN HIS CAPACITY AS ACTING MAYOR OF THE CITY OF BACOOR.

WHEREAS, the City Mayor, Hon. Strike B. Revilla, went on official leave on 18 December 2015 resulting in his appointment of Vice Mayor Catherine S. Evaristo as Acting City Mayor and the appointment of Hon. Avelino B. Solis, the city councilor who garnered the highest number of votes during the 2013 local elections, as Acting Vice Mayor.

WHEREAS, Acting City Mayor Evaristo went on official leave on 1 January, 2016 and appointed Hon. Solis as Acting City Mayor so as not to disrupt the delivery of basic services to the public.

WHEREAS, the Bids and Awards Committee (BAC) of the city promulgated Resolution No. 2016-002 on 5 January 2016 recommending the approval of the extension of the contract for the collection, hauling and disposal of the garbage generated by the City of Bacoor for the month of January 2016 with S.B. HAIN ENTERPRISES & GENERAL SERVICES subject to the ratification of the Sangguniang Panlungsod. The said contract expired on 31 December 2015.

WHEREAS, it appears from official records submitted to the Sangguniang Panlungsod that the said BAC Resolution was made necessary by the non-participation of any interested party in the bidding conducted on 5 January 2016 for the procurement of services for the collection, hauling, and disposal of garbage generated by the City of Bacoor previously awarded to S.B. HAIN ENTERPRISES & GENERAL SERVICES.

WHEREAS, on account of the non-participation of any party to the said bidding and in light of the accumulation of uncollected garbage on the city's thoroughfares which seriously endangered

public health as confirmed by Dr. Ivy Marie Yrastorza, the City Health Officer, the BAC recommended the extension of the above-mentioned contract due to lack of material time to conduct a re-bidding pursuant to Government Procurement Policy Board (GPPB) Resolution No. 23-2007 dated 28 September 2007 (otherwise known as the "Approving and Adopting the Revised Guidelines on the Extension of Contracts for General Support Services") which allows the extension of an on-going contract for a period not exceeding six (6) months.

WHEREAS, a Supplemental Contract for Collection, Hauling and Disposal of Residential Waste was executed by the City of Bacoor (represented by Hon. Solis in his capacity as Acting City Mayor) and by S.B. HAIN ENTERPRISES & GENERAL SERVICES (represented by Ms. Aurora C. Hain) in order to avert any garbage crisis in the City of Bacoor which, if not timely addressed and attended to, will adversely affect the health and welfare of city residents.

WHEREAS, a copy of the said BAC Resolution No. 2016-002 and of the said Supplemental Contract for Collection, Hauling and Disposal of Residential Waste were submitted for the review, consideration and ratification of the Sangguniang Panlungsod.

WHEREAS, the council reviewed the terms and conditions of the Supplemental Contract for Collection, Hauling and Disposal of Residential Waste as well as the legal implications of BAC Resolution No. 2016-002 and weighed the ramifications of both on public health and welfare.

WHEREAS, after extensive deliberations on the aforementioned recommendation of the BAC and after consultation with various resource persons, the Sangguniang Panlungsod unanimously concluded that the said Supplemental Contract for Collection, Hauling and Disposal of Residential Waste not only rested on solid legal ground but also averted a serious public health nightmare that would have come just a few days after the start of the New Year.

WHEREAS, the members of the Sangguniang Panlungsod believe that during extraordinary times such as that narrated above, the application of procedural technicalities with pedantic rigor must be avoided if an unthinking adherence thereto would imperil public health and welfare.

NOW THEREFORE, upon joint and unanimous motion of the Sangguniang Panlungsod, in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to: (a) **RATIFY** the Supplemental Contract for Collection, Hauling and Disposal of Residential Waste
