WHEREAS, the Department of Health has a program known as "Kalusugan Pangkalahatan" which envisions to make quality health care more accessible to the poor and to vulnerable sectors of the population by giving mobile health facilities such as mobile dental clinics to various local government units;

WHEREAS, the DOH intends to donate a mobile dental clinic with various dental equipment to the City Government of Bacoor pursuant to the said program;

WHEREAS, a draft Deed of Donation encompassing the said donation was sent by the Office of the City Mayor to the Sangguniang Panlungsod for its review and consideration;

NOW, THEREFORE, upon motion of Hon. Roberto Javier duly seconded by Hon. Reynaldo D. Palabrica in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor, Hon. Strike B.
