A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT WITH PROPERTY COMPANY OF FRIENDS, INC. REGARDING THE CONSTRUCTION OF AN ALTERNATIVE ROAD WITHIN THE VICINITY OF THE LAS PIÑAS-MUNTINLUPA-LAGUNA-CAVITE LINK ROAD (OTHERWISE KNOWN AS "DAANG HARI") TO MITIGATE TRAFFIC CONGESTION AT THE DAANG HARI-MOLINO ROAD INTERSECTION WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF BACOOR, CAVITE.

WHEREAS, the Las Piñas-Muntinlupa-Laguna-Cavite Link Road (otherwise known as the "Daang Hari") was developed to improve the overall traffic situation and road accessibility of the province of Cavite to and from Southern Metro Manila.

WHEREAS, the construction of a flyover by the Department of Public Works and Highways (DPWH) at the intersection of Daang Hari and the Molino-Salawag-Paliparan Road (also known as "Molino Road") denominated as "FLYOVER AT MOLINO-DAANG HARI ROAD INTERSECTION (Contract ID No. 15D00082)" under the budget of the DPWH for FY 2016 slated to begin during the second quarter of this year is expected to further worsen traffic congestion at the said crossroad especially during rush hours.

WHEREAS, PROPERTY COMPANY OF FRIENDS, INC., (also known as "ProFriends") a corporation duly organized and existing under any by virtue of the laws of the Republic of the Philippines, with principal place of business at 55 Tinio Street, Brgy. Addition Hills, Mandaluyong City approached the city government with a proposal to construct an alternative road within the vicinity of the Daang Hari-Molino Road area in order to assist in decongesting traffic in the above-mentioned intersection at no cost to the city government.
