A RESOLUTION APPROVING THE PROJECT PROPOSAL OF PHINMA PROPERTY HOLDINGS CORPORATION (PHINMA) WITH REGARD TO THE DEVELOPMENT AND CONSTRUCTION OF THE SOCIALIZED HOUSING PROJECT OF THE CITY OF BACOR TO BE KNOWN AS "STRIKEVILLE 5 HOMES" AND AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA TO SIGN THE MEMORANDUM AGREEMENT BETWEEN PHINMA AND THE CITY OF BACOR.

WHEREAS, the city government of Bacoor, Cavite have consistently upheld the right to a decent abode of its residents as evidenced by the launching of its various socialized housing projects over the years.

WHEREAS, PHINMA Property Holdings Corporation submitted an unsolicited proposal to the city government on 4 August 2015 for the development and construction of a socialized housing project of the city government situated at Barangay Zapote, Bacoor City, Cavite to be known as "Strikeville 5 Homes".

WHEREAS, in compliance with the various pertinent provisions of the law, an "INVITATION FOR COMPARATIVE/COMPETITIVE PROPOSAL" was published by the Public Private Partnership Committee of the City of Bacoor on 23 December 2015 in the Malaya newspaper. Despite the said publication and the lapse of the period within which to submit a Swiss challenge, no third party submitted any challenge to the said unsolicited proposal.

WHEREAS, a copy of the Memorandum of Agreement between the City of Bacoor and PHINMA was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for review and consideration.

WHEREAS, after reviewing and deliberating on the said Memorandum of Agreement, the Sangguniang Panlungsod concluded that the terms and conditions provided in the said document are advantageous to the city government and are not contrary to law.
