WHEREAS, numerous residents of the City of Bacoor have requested the City Government of Bacoor for assistance in relation to treatment of drug dependents who wish to undergo voluntary rehabilitation.

WHEREAS, the City Government of Bacoor desires to extend free medical treatment and rehabilitation services to the above-mentioned residents of the city down to the barangay level in partnership with health institutions taking care of drug dependents.

WHEREAS, the **Department of Health—Treatment and Rehabilitation Center (DOH-TRC)** in Tagaytay City, Cavite is a government-run residential treatment facility for substance dependency offering a holistic treatment approach that includes strategies for the restoration of the body, mind, emotions and human spirit. The treatment methods employed in the said facility upholds human dignity and is based on a sound understanding of drug addiction and the drug dependent as a person worthy of quality treatment and rehabilitation services.
