WHEREAS, on October 26, 2015, the Sangguniang Panlungsod has approved City Resolution No CR 2015-174 entitled "A resolution authorizing the City Mayor to sign a Memorandum of Agreement for and in behalf of the City Government of Bacoor with the Department of Science and Technology (DOST) IV-A, Department of the Interior Local Government (DILG), Office of the Civil Defense (OCD) IV-A, Local Government Units of Tanauan, Sta. Rosa and Carmona Regarding the Enhancement of Smart City Intelligence Operations Command (IOC) Center Project".
