CR 2015-097.

WHEREAS, the City Government accepted the said donation as evidenced by City Resolution No. CR-2015-097 that was passed on June 29, 2015 by the Sangguniang Panlungsod a copy of which is attached hereto as Annex "A".

WHEREAS, the Homeowners Association of F & E de Castro Subdivision requested the Sangguniang Panlungsod to authorize Maynilad Water Services Inc. (MAYNILAD) to begin pipe-laying activities in the said subdivision.
