Strike B. Revilla, on behalf of the City of Government of Bacoor and by Household Development Corporation regarding the donation of various open spaces located in various residential subdivisions in the City of Bacoor, Cavite."

**WHEREAS**, the said resolution involved the donation of a parcel of land under TCT No. 323304 with a total area of 5,688 square meters located at Springville Central 2 in favor of the city government.

**WHEREAS**, a draft Deed of Usufruct was submitted by the Office of the City Mayor involving the said lot for the review and consideration of the Sangguniang Panlungsod.

**WHEREAS**, in the Deed of Usufruct, a two hundred (200)-square meter portion of the said lot will be the future site of "Inay Maria Ng Magnificat Parish Church."

**NOW THEREFORE**, upon unanimous motion of Sangguniang Panlungsod, in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to pass a resolution authorizing the Hon. Molino as the future site Of "Inay Maria Ng Magnificat Parish Church."






