WHEREAS, the said posts are already leaning and also hold cable TV and telephone wires which are already dangling along the said streets.

WHEREAS, considering that the promotion of public safety and convenience is one of the duties of the Sangguniang Panlungsod, the members of the council are of the opinion that the request of the complainants mentioned above for the transfer of the location of the said electric posts should be seriously considered by the MERALCO.

Laurel Streets in Aniban I, Bacoor Cavite for reasons of public safety and convenience.
