WHEREAS, on May 17, 2016, pursuant to Republic Act 9165 (the Comprehensive Dangerous Drug Act of 2002), the Bacoor PNP conducted a buy-bust operation that lead to the arrest of a suspected drug pusher and the recovery of 10.4 kilograms of metamphetamine hydrochloride, commonly known as "shabu" with an estimated street value of Twenty Six Million Pesos (Php 26,000,000.00).
