A RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE BUREAU OF FISHERIES AND AQUATIC RESOURCES REGION IV-A ON THE "MANGROVE REFORESTATION PROJECT" FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACoor.

WHEREAS, in line with its mandate under Republic Act No. 8550 (the 1998 Philippine Fisheries Code), BFAR aims to achieve food security to promote sustainable development of fisheries resource and to reduce poverty incidence among fisher folk and other disadvantaged groups.

WHEREAS, the BFAR in collaboration with the local government concerned is implementing the "Mangrove Reforestation Project" in preparation for the Aquasilviculture Project and which aims to ensure resource sustainability, to attain food security and to alleviate poverty.

WHEREAS, the parties herein, willfully and jointly agree to extend full support and cooperation for the effective implementation of the above-mentioned project, which will be implemented from January 2016 to June 2016.

NOW THEREFORE, on motion of Councillor Gaudencio P. Nolasco duly seconded by all the councillors present in regular session, **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod to authorize the City Mayor, Hon. Strike B. Revilla, to sign and enter into a Memorandum of Agreement (MOA) with the Bureau of Fisheries and Aquatic Resources Region IV-A on the "Mangrove Reforestation Project" for and on behalf of the City Government of Bacoor.
