A RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE – BUREAU OF FISHERIES AND AQUATIC RESOURCES (DA-BFAR) REGION IV-A REGARDING THE BOTTOM-UP-BUDGETTING (BUB) PROJECT OF TEN (10) MOTORIZED FISHING BANCAS WITH FISHING PARAPHERNALIA FOR THE FISCAL YEAR 2016 AMOUNTING TO EIGHT HUNDRED THOUSAND PESOS (PhP 800,000.00).
