WHEREAS, it has come to the attention of the Sangguniang Panlungsod that the Maynilad Water Services Inc. ("Maynilad") has an ongoing promo wherein new water services subscribers residing within the City of Bacoor would only be required to pay a connection fee of only P500.00 instead of P8,500.00.

WHEREAS, the said promo is slated to end on 30 July 2016. Unfortunately, very few residents of the City of Bacoor are aware of the said promo.

WHEREAS, the Sangguniang Panlungsod is of the opinion that the city government and the various barangays of the City of Bacoor should mobilize its resources and inform the public about the said promo. However, the said promo should be extended in order to give various barangays officials more time to inform their respective constituents about the said promo.

NOW THEREFORE, upon motion of Councilor Reynaldo D. Palabrica, unanimously seconded by the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod in regular session duly assembled to pass a resolution requesting the Maynilad Water Services Inc. to extend its special discount promo for new water subscribers that would expire on 30 July 2016 for another thirty (30) days to give residents of the City of Bacoor more time to avail of the said promo.

RESOLVED FURTHER, to furnish the Maynilad Water Services, Inc., and all government offices concerned with copies of this resolution.






