CITY RESOLUTION NO. CR2016-080

A RESOLUTION RESPECTFULLY RECOMMENDING TO THE CITY MAYOR, HON. LANI MERCADO-REVILLA, THE AMENDMENT OF EXECUTIVE ORDER NO. 24-3T SERIES OF 2013 ISSUED BY FORMER CITY MAYOR, HON. STRIKE B. REVILLA, ON 28 NOVEMBER 2013 BY LIMITING THE AUTHORITY GRANTED THEREIN TO MR. ERNESTO C. LANUZA ADMINISTRATOR OF VARIOUS OPEN SPACES AND RECREATIONAL FACILITIES WITHIN PHASES 1 AND 5 OF BAHAYANG PAG-ASA SUBDIVISION, BARANGAY MOLINO V, BACOR CITY, CAVITE.

**WHEREAS**, the Sangguniang Panlungsod approved Municipal Resolution No. 71, Series of 2011 on 18 April 2011 entitled: "A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR HON. STRIKE B. REVILLA, TO SIGN THE MEMORANDUM OF AGREEMENT AMONG THE BAHAYANG PAGASA HOMEOWNER'S ASSOCIATION, INC., BARANGAY MOLINO V, BACOR CAVITE, AND THE MUNICIPAL GOVERNMENT OF BACOR, CAVITE REGARDING THE USE AND MANAGEMENT OF CERTAIN GOVERNMENT OWNED RECREATIONAL FACILITIES WITHIN BAHAYANG PAGASA, MOLINO V, BACOR, CAVITE".

**WHEREAS**, by virtue of Municipal Resolution No. 71-S-2013, former City Mayor Strike B. Revilla issued Executive Order No. 24-3T on 28 November 2013 appointing Mr. Ernesto C. Lanuza as the Administrator of the various open spaces and recreational facilities within Phases 1 and 5 of Bahayang Pag-asa Subdivision at Barangay Molino V, Bacor City, Cavite.

**WHEREAS**, Punong Barangay Samuel Sibayan of Barangay Molino V requested the Sangguniang Panlungsod to amend Municipal Resolution No. 71-S-2013 so as to enable the officers of the First Bahayang Pag-asa Homeowners' Association Inc. (FBPHAI) and the officials of the said barangay to manage and operate the said open spaces and recreational facilities with the exception of the Family Ecopark situated at Phase 1 of Bahayang Pag-asa Subdivision which is now being managed and administered by Mr. Lanuza.




