A RESOLUTION AUTHORIZING CONGRESSMAN STRIKE B. REVILLA, REPRESENTATIVE OF THE SECOND LEGISLATIVE DISTRICT OF THE PROVINCE OF CAVITE TO THE HOUSE OF REPRESENTATIVES, TO MAKE USE OF THE OFFICE LOCATED AT THE THIRD FLOOR OF THE BACOOR CITY HALL AS HIS PERMANENT SATELLITE OFFICE IN THE CITY OF BACOOR, CAVITE.

WHEREAS, the Sangguniang Panlungsod unanimously approved City Ordinance No. CO 38-2016 authorizing the establishment of a permanent satellite office at the third floor of the Bacoor City Hall for use by the representative of the Second Legislative District of the Province of Cavite to the House of Representatives.

WHEREAS, Congressman Strike B. Revilla was the former local chief executive of the City of Bacoor, Cavite and it was during his incumbency as City Mayor that Bacoor became a city and the new Bacoor City Hall was constructed.

WHEREAS, as the city's representative to the House of Representatives, Congressman Revilla is also a member of the Local Development Council which makes it necessary for him to be in constant touch with the other members of the said body in the charting and planning of future development plans for the City.

WHEREAS, the existence of a satellite office within the Bacoor City Hall for use of the city's representative to Congress shall enable the said official to become more accessible to city residents in need of his assistance.

NOW THEREFORE, upon motion of Councilor Venus De Castro unanimously seconded by the rest of the body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize Congressman Strike B. Revilla, representative of the Second Legislative District of the Province of Cavite to the House of Representatives, to make use of the office located at the third floor of the Bacoor City Hall as his permanent satellite office in the City of Bacoor, Cavite.
