**A RESOLUTION DECLARING GEORGETOWN HEIGHTS SUBDIVISION PHASE I, MOLINO IV, BACOR CITY, CAVITE AS AN "ABANDONED SUBDIVISION" FOR THE EXCAVATION AND INSTALLATION OF WATER PIPELINES BY MAYNILAD WATER SERVICES, INC. IN RELATION TO ITS NATIONAL WATER AND SEWERAGE SERVICES PROJECT.**
