A RESOLUTION GRANTING THE BAHAYANG PAG-ASA PHASE 1 TENNIS CLUB, INC. WITH THE AUTHORITY TO MANAGE AND ADMINISTER THE TENNIS COURT LOCATED AT PHASE 1, BAHAYANG PAG-ASA, MOLINO V, BACOR CITY, CAVITE SUBJECT TO CERTAIN CONDITIONS HEREIN SET FORTH.

WHEREAS, the officers of the Bahayang Pag-asa Phase 1 Tennis Club, Inc. formally petitioned the Sangguniang Panlungsod to grant it the authority to manage and administer the tennis court located at Phase 1, Bahayang Pag-asa, Molino V, Bacoor City, Cavite in order to ensure that the said sports facility shall be well maintained and shall be accessible to all the residents of the said residential subdivisions.

WHEREAS, the records of the city council show that the local government of the City of Bacoor owns the said tennis court, along with all other open spaces within Bahayang Pag-asa Subdivision.

WHEREAS, the above-mentioned petitioners assured the council that their organization would agree to any condition set forth by the Sangguniang Panlungsod in exchange for the approval of their request.

NOW THEREFORE, after careful deliberation on the afore-mentioned matter and upon motion of Councilor Venus D. De Castro, duly seconded by Councilor Reynaldo D. Palabrica, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod in regular session assembled to authorize the Bahayang Pag-asa Phase 1 Tennis Club, Inc. to administer and manage the tennis court located in Phase 1 of Bahayang Pag-asa Subdivision, Brgy. Molino V, Bacoor City, Cavite.

- a. The officials of Bahayang Pag-asa Phase 1 Tennis Club, Inc. would ensure that the said tennis court shall always be clean and well-maintained;
- b. The officials of the said organization shall ensure that the drinking of alcoholic beverages of whatever quantity, the smoking of cigarettes, and the conduct of any lewd, immoral, or illegal activity shall be strictly prohibited within the said tennis court and in its immediate environs;
- c. The various rates to be charged by the Bahayang Pag-asa Phase 1 Tennis Club, Inc. for use of the said facility shall be subject to the written approval by at least a majority of the members of the Sangguniang Panlungsod by way of an ordinance;
- d. The officials of Barangay Molino V may also use the said tennis court free of charge for official functions subject to consultation with the officials of the Bahayang Pag-asa Phase 1 Tennis Club, Inc. Provided, that in case of conflict in the interpretation or implementation of this provision, such conflict shall be resolved by the City Mayor. The decision of the City Mayor in that regard shall be final;
- e. The tennis court shall be open to any person who is willing to abide by the rules of the Bahayang Pag-asa Phase 1 Tennis Club, Inc. and to pay the rates mentioned above;
- f. Ownership of the said tennis court shall not be transferred to Bahayang Pag-asa Phase 1 Tennis Club, Inc. and the same would remain the property of the City Government of Bacoor City, Cavite;
- g. Barangay Molino V would willingly and immediately vacate the said open space upon written demand by the City Mayor;
- h. The officials of Bahayang Pag-asa Phase 1 Tennis Club, Inc. would ensure that the said tennis court would be operated in accordance with relevant environmental laws and pertinent government regulations; and
- i. Any violation of the foregoing conditions shall result in the immediate revocation of the authority granted herein

RESOLVED MOREOVER, this Resolution shall take effect immediately after it has been published once in a local newspaper of general circulation and after it has been posted on the bulleting board at the entrance of the city hall and in two other conspicuous places within the City of Bacoor.






