**WHEREAS**, the public health centers in the City of Bacoor do not have complete facilities capable of rendering services like Ceasarean section and the management of high risk patients;

**WHEREAS**, the City Government of Bacoor has established a partnership and referral system with other health service providers/facilities in order to address such need and also to improve the delivery of quality health care services to patients;

**WHEREAS**, the Molino Doctors Hospital has a diagnostic facility for the use, treatment and further medical management of patients who may be referred by the city government;

**WHEREAS**, the Office of the City Mayor submitted a draft Memorandum of Agreement to the Sangguniang Panlungsod for review and approval;

**NOW, THEREFORE**, after careful deliberation, upon unanimous motion of all the councilors present in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor, Lani Mercado-Revilla, to sign and enter into a Memorandum of Agreement with the Molino Doctors Hospital for and on behalf of the Bacoor City Government.
