**WHEREAS**, the Office of the City Mayor submitted a draft Contract of Services between the City Government of Bacoor and the marching bands that will participate in the Bakood Festival for review and consideration of the Sangguniang Panlungsod;

**WHEREAS**, the abovementioned subject was referred to the Committee on Tourism, Culture and Linkages headed by Councilor Rowena Bautista-Mendiola and to the Committee on Rules, Privileges, Laws and Ordinances headed by Councilor Venus de Castro respectively, for further study and evaluation;

**WHEREAS**, Joint Committee Report No. 2016-055 was submitted to the council recommending to pass a resolution authorizing the city mayor to sign the Contract of Service with various marching bands on behalf of the city government subject to the Implementing Rules and Regulation of Republic Act 9184 or the "Government Procurement Reform Act".


