A RESOLUTION REQUESTING THE LOCAL GOVERNMENT OF THE CITY OF IMUS, CAVITE TO ALLOW TRICYCLES OPERATED BY TRICYCLE OPERATORS AND DRIVERS ASSOCIATIONS (TODAs) DULY ACCREDITED WITH THE BACOOOR TRAFFIC MANAGEMENT DEPARTMENT (BTMD) PLYING MAMBOG ROAD TO UNLOAD PASSENGERS ON THE CORNER OF AGUINALDO HIGHWAY FOR THE CONVENIENCE OF THE RIDING PUBLIC AND RESPECTFULLY REQUESTING CAVITE PROVINCIAL GOVERNOR JESUS CRISPIN C. REMULLA TO INTERCEDE BETWEEN THE CITY OF BACOOOR AND THE CITY OF IMUS REGARDING THE ABOVE-MENTIONED MATTER.

WHEREAS, Ms. Torres further avers that, like her, many residents of Mambog, Bacoor City, Cavite are greatly inconvenienced by the alleged "misunderstanding" between the two local governments mentioned above.

WHEREAS, the said complaint was then forwarded by the CSC to the Office of Cavite Provincial Governor, Atty. Jesus Crispin C. Remulla, for appropriate action.

WHEREAS, Governor Remulla then forwarded the said complaint to the Sangguniang Panlungsod of the City of Bacoor for appropriate action.

WHEREAS, the Sangguniang Panlungsod conducted an inquiry on the said complaint and discovered that former Mayor (now Congressman) Strike B. Revilla met with Mayor Manny Maliksi of the City of Imus on several occasions in order to arrive at an amicable solution to the problem of commuters residing in Barangay Mambog, Bacoor City, Cavite who are headed to the City of Imus via Mambog Road on tricycles accredited as public utilities by the Bacoor Traffic Management Department. However, all such efforts proved futile.

NOW THEREFORE, upon motion of Councilor Reynaldo Palabrica, unanimous seconded by the rest of the body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod of the City of Bacoor to respectfully request the local government of the City of Imus to allow tricycles operated by Tricycle Operators and Drivers Associations (TODAs) duly accredited with the Bacoor Traffic Management Department (BTMD) traversing Mambog Road to unload passengers on the corner of Aguinaldo Highway which is within the jurisdiction of the City of Imus for the convenience of the riding public and respectfully requesting Cavite Provincial Governor Jesus Crispin C. Remulla to intercede between the City of Bacoor and the City of Imus regarding the above-mentioned matter.

RESOLVED FURTHER, to furnish the Office of the Provincial Governor, the Office of the Mayor of the City of Imus, and the Civil Service Commission (CSC) with certified true copies of this Resolution.

UNANIMOUSLY APPROVED this 5th day of September 2016 at the City of Bacoor during the 9th regular session of the 3rd Sangguniang Panlungsod of the City of Bacoor.
