A RESOLUTION CONDEMNING THE TERRORIST ATTACK THAT TOOK PLACE AT THE CITY OF DAVAO ON 2 SEPTEMBER 2016, EXTENDING THE SINCEREST CONDOLENCES OF THE PEOPLE OF THE CITY OF BACOR TO THE FAMILIES OF THE VICTIMS OF THE SAID TERRORIST ACT, AND DECLARING THE SOLIDARITY OF THE LOCAL GOVERNMENT OF THE CITY OF BACOR WITH THE LOCAL GOVERNMENT OF ITS SISTER CITY, THE CITY OF DAVAO.

**WHEREAS**, the improvised explosive device that tore through the City of Davao on the night of September 2, 2016 did not only cause the death of fourteen people and the maiming of many more. It also reminded the people of this republic that constant vigilance is the price of peace, that evil still lurks in the midst of hope, and that cowards still use terror in order to impose their misguided beliefs upon the sovereign will of a determined people. Unsurprisingly, the local government of the City of Davao under the leadership of its indefatigable Mayor, Sara Z. Duterte-Carpio, ordered the immediate reopening of the night market where the terrorist attack took place in order to show to the perpetrators of that sinister act that the people of the City of Davao remains unbowed and defiant.

**WHEREAS**, the officials of the local government of the City of Bacoor vehemently condemn this act of terrorism.

**WHEREAS**, in the face of this terrorist attack, the people of the City of Bacoor sincerely condole with those who have lost their loved ones and declares its solidarity with the people of the City of Davao.
