A RESOLUTION REQUESTING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO ORDER THE MANDATORY DRUG TESTING OF ALL CITY OFFICIALS AND EMPLOYEES PURSUANT TO THE RELEVANT PROVISIONS OF CITY ORDINANCE NO. CO 17-2016 (OTHERWISE KNOWN AS THE "ANTI-SUBSTANCE ABUSE PROGRAM ORDINANCE OF THE CITY OF BACOR") AND REPUBLIC ACT NO. 9165 (ALSO KNOWN AS THE "COMPREHENSIVE DRUG ABUSE ACT OF 2002").

Duterte's ongoing campaign against drug syndicates and drug abuse.

WHEREAS, unidentified sources have reported to various members of the Sangguniang Panlungsod that some city government officials and employees are still hooked on drugs despite numerous opportunities given to them to turn a new leaf.

WHEREAS, City Ordinance No. CO 17-2016 empowered the City Mayor to order mandatory drug testing on all city government employees and officials.


