A RESOLUTION AUTHORIZING THE CITY MAYOR, LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR WITH THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA) REGARDING THE BOTTOM-UP BUDGETING (BUB) PROJECTS AMOUNTING TO ONE MILLION FOUR HUNDRED NINETY EIGHT THOUSAND AND THREE HUNDRED PESOS (PHP1,498,300.00).

WHEREAS, the Bottom-Up Budgeting (BUB) program of the national government primarily empowers the grassroots organizations in local government units (LGUs) in identifying priority poverty reduction projects that will be funded by national agencies.

WHEREAS, the BUB is an approach to prepare budget proposals of agencies taking into consideration the identified development needs of cities/municipalities in their respective local poverty action plans.

WHEREAS, the Qualification Map (QM) for BUB is developed to include the physical and financial details of the training program and the period of its implementation which is contained within the prescribed validity period for Calendar Year 2016 as per Technical Education and Skills Development Authority (TESDA) Circular No. 12, Series of 2016.

WHEREAS, the TESDA shall pay the following cost with the total amount of One Million Four Hundred Ninety Eight Thousand Three Hundred Pesos (PhP1,498,300.00), as stipulated in the Memorandum of Agreement (MOA), to wit: (1) Training Cost - **PhP943,500.00**; (2) Entrepreneurship - **PhP176,000.00**; (3) Assessment Fees - **PhP110,000.00**; and (4) Training Support Fund - **PhP268,800.00**.

WHEREAS, the training shall be provided by the Technical Vocational Institutions (TVIs) with TESDA registered programs as identified by the City Government of Bacoor;

WHEREAS, the City Government of Bacoor is always finding ways to empower its people and is a willing partner in the implementation of the said program.
