A RESOLUTION AUTHORIZING THE CITY MAYOR, LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOOR WITH THE DEPARTMENT OF SCIENCE AND TECHNOLOGY-REGION IVA (DOST-CALABARZON) REGARDING THE IMPLEMENTATION OF THE PROJECT ENTITLED "IMPROVEMENT FOR STREET FOOD VENDING AS COMMUNITY - BASED LIVELIHOOD OPPORTUNITIES FOR VENDORS OF THE LOCAL GOVERNMENT UNIT (LGU) OF BACOOR" AND PROVIDING FINANCIAL ASSISTANCE TO BE GRANTED TO THE CITY GOVERNMENT AMOUNTING TO FOUR HUNDRED THOUSAND AND TEN PESOS (PHP 400,010.00).

**WHEREAS**, the Department of Science and Technology-Region IVA (DOST-CALABARZON) provides direction, leadership and coordination of all scientific and technological services being delivered by the government for the economic and social benefit of the people;

**WHEREAS**, the Office of the City Mayor of the local government of the City of Bacoor provide livelihood opportunities to city residents who are economically marginalized while promoting food safety in street food vending activities;

**WHEREAS**, the Office of the City Administrator requested the Sangguniang Panlungsod in writing to review a draft Memorandum of Agreement between the city government and the DOST-CALABARZON and to pass a resolution authorizing the City Mayor to sign the said contract.

**WHEREAS**, a review of the said agreement showed that the DOST-CALABARZON intends to grant financial aid amounting to Four Hundred Thousand and Ten Pesos (PhP400,010.00) as well as technical assistance to the City Government of Bacoor through the so-called "Livelihood Development Office" for the implementation of the project entitled, "Improvement for Street-Food Vending as Community - Based Livelihood Opportunities for Vendors of the local government unit (LGU) of Bacoor".

**WHEREAS**, the Sangguniang Panlungsod deliberated on the provisions of the said agreement and found the provisions thereof to be in accordance with law with the exception of the provisions

Gutierrez in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor, Lani Mercado-Revilla, to sign and enter into a Memorandum of Agreement for and on behalf of the City Government of Bacoor with the DOST-CALABARZON regarding the implementation of the project entitled: "Improvement For Street Food Vending As Community - Based Livelihood Opportunities For Vendors Of The Local Government Unit (LGU) Of Bacoor" and providing financial assistance to be granted to the city government amounting to Four Hundred Thousand And Ten Pesos (Php 400,010.00). **Provided** that the authority granted herein is on the condition that the provisions of the Memorandum of Agreement should be revised such that (a) the financial grant and technical assistance mentioned above should be given directly to the city government, and (b) it is the City Mayor who should sign the agreement on behalf of the city government.

**RESOLVED LASTLY**, to furnish the DOST Region IVA, and various government offices concerned with copies of this Resolution.
