WHEREAS, the Sangguniang Panlungsod received a request from the City Mayor, Hon. Lani Mercado-Revilla, to commend various officers of the Philippine National Police (PNP) assigned at the City of Bacoor under the leadership of P/Supt. Christopher F. Olazo for their commendable performance during a buy-bust operation that took place on 30 July 2016 resulting in the death of a former police officer suspected of being engaged in illegal drugs trade, the confiscation of a firearm, and the seizure of 1.08 grams of shabu.

WHEREAS, an accomplishment report signed by P/Supt. Olazo was attached to Mayor Mercado-Revilla's request.

WHEREAS, a review of the said report and of various data culled by the city council from various reliable sources revealed that the efforts of the Bacoor PNP has significantly stemmed the spread of criminality within the city. Consequently, the city council believes that the City Mayor's request is meritorious and should be immediately granted.
