A RESOLUTION AUTHORIZING THE CITY MAYOR, LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A CONTRACT OF LEASE WITH THE MANILA ELECTRIC COMPANY FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOOR FOR THE PURPOSE OF RENTING AN OFFICE ON THE LOWER GROUND FLOOR OF THE BACOOR GOVERNMENT CENTER.

**WHEREAS**, the Office of the City Mayor submitted a draft copy of a Contract of Lease between the City Government of Bacoor and the Manila Electric Company for the renting out of an office space at the lower ground floor of the Bacoor City Hall at the Bacoor Government Center to the Sangguniang Panlungsod for review and evaluation;

**WHEREAS**, after a careful deliberation and consideration of the provisions of the draft Contract of Lease which the council found to be advantageous to the City Government of Bacoor;

**NOW THEREFORE**, upon motion of Councilor Gaudencio P. Nolasco and unanimously seconded by all the members present, in its 13<sup>th</sup> regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod of Bacoor, Province of Cavite to authorize the City Mayor, Lani Mercado-Revilla, to sign and enter into a Contract of Lease with the Manila Electric Company (MERALCO) for and on behalf of the City Government of Bacoor for renting an office space at the Lower Ground Floor (Unit LG01) of the Bacoor Government Center.

**RESOLVED LASTLY**, to furnish the MERALCO and all concerned government offices with copies of this resolution.
