A RESOLUTION DIRECTING M.E. SICAT CONSTRUCTION INC. AND OTHER PRIVATE CONTRACTORS WORKING ON ROAD IMPROVEMENT PROJECTS WITHIN THE CITY OF BACOOR TO USE QUICK-DRYING CEMENT IN PATCHING UP THE ROAD SECTIONS THEY ARE EXCAVATING IN ORDER TO MINIMIZE TRAFFIC CONGESTION.

WHEREAS, the Sangguniang Panlungsod passed City Resolution No. CR2016-007A on 11 January 2016 directing M.E. Sicat Construction Inc. to consider the traffic situation in the public roads mentioned above before it embark on the pipe-laying projects of the Maynilad Water Services Inc. ("Maynilad") on the following roads located within the City of Bacoor, Cavite: Magdiwang Road, GSIS Road, Green Valley Road, Queensrow East Road and Queens Avenue. Despite the said directive, M.E. Sicat Construction Inc. still proceeded with the project in a manner that causes undue hardship to the public.

WHEREAS, as a consequence of the failure of M.E Sicat Construction Inc. to heed the directive contained in City Resolution No. CR2016-007A, numerous complaints from members of the commuting public has been received by the Sangguniang Panlungsod over the severe traffic congestions being caused everyday by the said pipe laying projects.

WHEREAS, an inquiry into the said complaints conducted by the city council revealed that part of the reason for the said traffic congestion is that the concrete being used by M.E. Sicat Construction Inc. takes seven (7) days to cure or dry up.

WHEREAS, further research conducted by the city council on the said matter revealed that a type of concrete that only takes three days to cure is available locally and that if the said construction material is used, the traffic congestion in the said area would be considerably reduced.
