A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A CONTRACT OF LEASE FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACCOOR WITH THE GLOBE TELECOM INC. FOR LEASING OUT THE PORTION OF PROPERTY LOCATED IN SAN LORENZO RUIZ VILLAGE, BRGY. MOLINO VII, BACCOOR CITY, CAVITE FOR THE CONSTRUCTION OF A CELLSITE TOWER, MACROCELLULAR ANTENNAS AND CABIN.

**WHEREAS**, each local government unit has the power to create its own source of revenues and to levy taxes, fees and charges subject to the provisions of the Local Government Code of 1991;

**WHEREAS**, Globe Telecom Inc. offered to lease the portion of the real property in San Lorenzo Ruiz Village, Molino VII, Bacoor City, Cavite with an area of 49 square meters for the construction of a cellsite tower and other telecommunications equipment.

**WHEREAS**, a draft Contract of Lease to be entered into by the City Government of Bacoor and Globe Telecom, Inc. was submitted to the Sangguniang Panlungsod for review and evaluation;

**WHEREAS**, after a careful deliberation and consideration of the provisions of the draft Contract of Lease, the council found its provisions to be advantageous to the City Government of Bacoor;

**NOW THEREFORE**, upon motion of Councilor Roberto R. Javier duly seconded by Councilor Apolonio Advincula, Jr. in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod of Bacoor to authorize the City Mayor, Hon. Lani Mercado-Revilla, to sign and enter into a Contract of Lease for and on behalf of the City of Government of Bacoor with the Globe Telecom Inc. for the leasing out of the 49-square meter portion of the property located in San Lorenzo Ruiz Village, Brgy. Molino VII, Bacoor City, Cavite for the construction and
