A RESOLUTION RESPECTFULLY REQUESTING CONGRESSMAN STRIKE B. REVILLA, REPRESENTATIVE OF THE 2ND LEGISLATIVE DISTRICT OF THE PROVINCE OF CAVITE, TO MAKE REPRESENTATIONS WITH THE DEPARTMENT OF TOURISM (DOT) ON BEHALF OF THE CITY GOVERNMENT FOR INCLUSION OF THE "MARCHING BAND FESTIVAL" OF THE CITY OF BACOR IN THE SAID AGENCY'S OFFICIAL CALENDAR OF FESTIVALS AND FOR THE ALLOCATION OF AT LEAST TWENTY MILLION PESOS (PHP 20,000,000.00) FROM THE BUDGET OF THE TOURISM DEPARTMENT IN SUPPORT OF THE HOLDING OF VARIOUS EVENTS RELATED TO THE CELEBRATION OF THE "2017 MARCHING BAND WORLD CHAMPIONSHIPS" IN THE CITY OF BACOR.

WHEREAS, the City of Bacoor has prided itself as the "Marching Band Capital of the Philippines" in recognition of the fact that some of the oldest marching bands in the country were first formed in Bacoor and have been playing music in social events like weddings and funerals all over the country since 1898.

WHEREAS, in recognition of the said cultural heritage, the city government has been celebrating the "Marching Band Festival" for many years. This year alone, fifty marching bands from all over the country took part in the said festival which was witnessed by thousands of spectators.

WHEREAS, the World Association of Marching Show Bands gave the Philippines the privilege of hosting the 2017 World Marching Band Championships to be participated in by various marching show bands all over Asia and Europe.

WHEREAS, despite the foregoing, the Marching Band Festival is not part of the official Calendar of Festivals being maintained by the Department of Tourism (DOT). Consequently, public awareness of the existence of the Marching Band Festival is very low thereby stunting the growth of the City of Bacoor as a tourist destination.

WHEREAS, several competition events related to the celebration of the 2017 World Marching Band Championships would be held in the City of Bacoor, wherein the competition categories that will happen on a week-long schedule includes marching showdown, solo instrument battles. However, the city government does not have sufficient funds that would ensure the successful holding of the said events. In view thereof, the Sangguniang Panlungsod has decided to respectfully request Congressman Strike B. Revilla, representative of the 2nd legislative district of the Province of
