A RESOLUTION AUTHORIZING THE CITY MAYOR, LANI-MERCADO REVILLA TO SIGN AND ENTER INTO A MEMORANDUM OF UNDERTAKING FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACoor WITH THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA) REGARDING THE IMPLEMENTATION OF THE PROJECT ENTITLED, "PROFESSIONALIZING LGU SKILLED WORKFORCE PROGRAM - A CAPACITY ENHANCEMENT PROGRAM".

**WHEREAS**, the Technical Education and Skills Development Authority (TESDA) formulates manpower and skills plans, sets appropriate skills standards and tests, coordinates and monitors manpower policies and programs, and provides policy directions and guidelines for resource allocation for the Technical Vocational Education and Training (TVET) institutions in the private and public sector.

**WHEREAS**, the TESDA has a community-based Training Program designed to address groups who cannot access or are not accessible by formal training provisions.

**WHEREAS**, the aim of the City Government of Bacoor is to develop and certify the competency of working age individuals residing within the city as well as provide skills training opportunities to the members of the community.

**WHEREAS**, the Memorandum of Undertaking (MOU) to be entered into by and between the city government and TESDA will support the city's goal of professionalizing its skilled workers and comply with the standards and systems set by the TVET sector.


