A RESOLUTION AUTHORIZING THE CITY MAYOR, LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOOR WITH CABLE LINK AND HOLDINGS CORPORATION FOR THE FREE USE OF FIBER OPTIC CABLES AND CABLE TV NETWORK FOR THE BACOOR COMMAND CENTER.

WHEREAS, the City Government of Bacoor operates a wireless Closed Caption Television (CCTV) camera system used for disaster risk management and traffic management activities which is controlled through the Bacoor City Command Center.

WHEREAS, the Cable Link and Holdings Corporation ("Cable Link") is a provider of quality products and services in the field of communications, information technology and entertainment operating within the City of Bacoor.

WHEREAS, the Cable Link offered the free use of its fiber optic cables and cable television facilities to the city government that will be connected to the latter's wireless CCTV camera system connection within the City of Bacoor.

WHEREAS, the City Government of Bacoor is willing to accept the offer of Cable Link.

WHEREAS, a draft copy of the Memorandum of Agreement was sent by the Office of the City Mayor to the Sangguniang Panlungsod for its review and consideration.
