A RESOLUTION RESPECTFULLY RECOMMENDING TO THE CITY MAYOR THE TERMINATION FROM SERVICE OF MR. RONALDO DINCO BERENGUEL, TRAFFIC ENFORCER OF THE BACoor TRAFFIC MANAGEMENT DEPARTMENT (BTMD), FOR COMMITTING ABUSE OF AUTHORITY DURING THE PERFORMANCE OF DUTIES EFFECTIVE ON NOVEMBER 16, 2016.

WHEREAS, the Sangguniang Panlungsod received a complaint filed by spouses Christopher and Maricel Llanita against Mr. Ronaldo Dinco Berenguel, Traffic Enforcer of the Bacoor Traffic Management Department (BTMD) for abuse of authority;

WHEREAS, the said complaint was deliberated upon by the Sangguniang Panlungsod Committee En Banc under the Committee on Ethics, Appointments and Government Reorganization through its Vice-Chairman, Hon. Reynaldo D. Palabrica;

WHEREAS, Mr. Ronaldo Dinco Berenguel was invited to a hearing by the Committee on Ethics, Appointments and Government Reorganization held on 9 November 2016. During the said hearing, Mr. Berenguel was informed that he has a right to counsel but he waived the said right.

WHEREAS, Mr. Berenguel has on record in the Office of the Sangguniang Panlungsod, another complaint filed against him in April, 2014 where he was also found guilty of an extortion case resulting in the approval of City Resolution No. 2014-104 recommending the imposition of the penalty of suspension from duty for two (2) consecutive weeks to the City Mayor against Berenguel.

WHEREAS, after an extensive deliberation of the said complaint, Mr. Berenguel was found to be indeed guilty of committing abuse of authority based from the result of the council's interrogation and testimonies of resource persons during the investigation;

WHEREAS, considering all of the above-quoted circumstances, the members of the Sangguniang Panlungsod who were present during the session voted to approve a resolution respectfully recommending to the City Mayor the termination from service of Mr. Ronaldo Dinco Berenguel, a personnel in the Bacoor Traffic Management Department (BTMD), for having been found guilty of committing abuse of authority during the performance of his duties as Traffic Enforcer, effective on November 16, 2016:


