A RESOLUTION RESPECTFULLY RECOMMENDING TO THE CITY MAYOR THE SUSPENSION FROM DUTY OF MR. DANIEL AGUADO, TRAFFIC ENFORCER OF THE BACOOR TRAFFIC MANAGEMENT DEPARTMENT (BTMD) FOR SIXTY (60) DAYS WITHOUT PAY FOR COMMITTING ABUSE OF AUTHORITY AND DISRESPECT OF A PUBLIC OFFICIAL DURING THE PERFORMANCE OF DUTIES EFFECTIVE ON NOVEMBER 16, 2016.

WHEREAS, the Sangguniang Panlungsod received a verbal complaint from Councilor Roberto R. Javier against Mr. Daniel Aguado, Traffic Enforcer of the Bacoor Traffic Management Department (BTMD), for abuse of authority;

WHEREAS, the said complaint was deliberated upon by the Sangguniang Panlungsod Committee En Banc under the Committee on Ethics, Appointments and Government Reorganization headed by its Chairman, Hon. Miguel N. Bautista;

WHEREAS, Mr. Aguado was informed that he has a right to counsel but he did not avail of the said right.

WHEREAS, after an extensive deliberation of the said complaint, Mr. Daniel Aguado was found to be guilty of committing abuse of authority based from the result of the council's interrogation and from the testimonies of resource persons present during the investigation;

WHEREAS, all of the members of the Sangguniang Panlungsod present during the session voted to approve a resolution recommending the suspension from duty of Mr. Aguado, for sixty (60) days without pay for having been found guilty of committing abuse of authority and disrespect of public official during the performance of his duties as Traffic Enforcer, effective on November 16, 2016;

NOW, THEREFORE, upon motion of Councilor Apolonio I. Advincula, Jr. unanimously seconded by all members of the Sangguniang Panlungsod in regular session assembled, **BE IT RESOLVED, AS IT IS HEREBY RESOLVED** to approve a resolution respectfully recommending to the City Mayor, Hon. Lani Mercado-Revilla, the suspension from duty of Mr. Daniel Aguado, Traffic Enforcer of the Bacoor Traffic Management Department (BTMD) for being guilty of committing abuse of authority and disrespect of public official while on active duty to be effective on November 16, 2016;






