WHEREAS, the Action Plan prescribes the guidelines and procedures relative to the conduct of holistic anti-crime approach by all sectors concerned to address criminal activities greater emphasis the campaign against drugs.

WHEREAS, the illicit drug activities are proliferated in the City of Bacoor and the crimes committed by criminal elements are mostly related to the prohibited drug use. The Bacoor City Police Stations in coordination with different sectors like government units, like the Provincial/City/Municipal/Barangay Anti-Drug Abuse Councils (ADACs), AFP units and other law enforcement agencies particularly the Police Drug Enforcement Authority (PDEA) and Non Government Organizations (NGOs) shall intensify its police operations against all forms of criminalities particularly those of illegal use of drugs.

WHEREAS, the PNP Anti-illegal Drugs Campaign Plan Project: "Double Barrel" will be conducted in two approaches namely: 1) **Project Tokhang** involves the conduct of house to house visitations to persuade suspected illegal drug personalities to stop their illegal drug activities; and 2) **Project HVT** is a massive and reinvigorated conduct of anti-illegal drugs operations targeting illegal drugs personalities and drug syndicates to be conducted by City Anti-Illegal Drugs Special Operation Task Force.

WHEREAS, the above-mentioned anti-criminality action plan of the Bacoor PNP entitled: "Adoption of PNP Anti-Illegal Drugs Campaign Thru Double Barrel Alpha" was submitted to the Sangguniang Panlungsod for review and consideration.

WHEREAS, the Sangguniang Panlungsod deliberated on the said action plan and unanimously decided to approve the same.
