






A RESOLUTION ALLOWING THE GRANT OF ADDITIONAL ALLOWANCES ON A QUARTERLY BASIS FOR FISCAL YEAR 2016 TO ALL PUBLIC SCHOOL TEACHERS OF THE DEPARTMENT OF EDUCATION STATIONED IN THE CITY OF BACOR SUBJECT TO AVAILABILITY OF FUNDS AND IN ACCORDANCE WITH APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES.

WHEREAS, the Office of the Sangguniang Panlungsod has passed City Resolution No. CR-2016-13A entitled "A Resolution Granting Additional Allowances to All Public School Teachers of the Department Of Education stationed in the City Of Bacoor subject to Availability of Funds".

WHEREAS, the City Government of Bacoor has allocated funds for the said grant of additional allowances as verified in City Ordinance No. CO 1A, Series of 2016 in Supplemental Budget No.1, to support the city government's various campaigns to educate the youth;




