A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH (DOH) REGIONAL HEALTH OFFICE 4A (CALABARZON) REGARDING THE IMPLEMENTATION OF HEALTH EMERGENCY MANAGEMENT SYSTEM (HEMS) TRAINING FOR HEALTH WORKERS WITH AN APPROVED BUDGET OF PHP 500,000.00 UNDER THE BOTTOM-UP BUDGETING PROGRAM FOR CALENDAR YEAR 2016.
