A RESOLUTION EXPRESSING THE SUPPORT OF THE SANGGUNIANG PANLUNGSOD OF THE CITY OF BACOOR TO THE APPROVAL OF HOUSE BILL NO. 4189 (RENAMING MOLINO BOULEVARD TO "BACOOR BOULEVARD") AND HOUSE BILL NO. 4190 (RENAMING THE MOLINO-SALAWAG-PALIPARAN ROAD INTO THE "BACOOR-DASMARIÑAS ROAD").

**WHEREAS**, Congressman Strike B. Revilla, Representative of the 2<sup>nd</sup> Legislative District of Cavite, sent copies of House Bill No. 4189 and House Bill No. 4190 to the Sangguniang Panlungsod together with a request for the city council to pass a resolution supporting the approval of the said bills.

**WHEREAS**, House Bill No. 4189 seeks the renaming of Molino Boulevard situated within the City of Bacoor into "Bacoor Boulevard" while House Bill No. 4190 intends to rename the Molino-Salawag-Paliparan Road which extends from the City of Bacoor to the adjoining City of Dasmariñas into the "Bacoor-Dasmariñas Road".

**WHEREAS**, the intention of Congressman Revilla to rename the said roads would benefit the public because the proposed names of the said thoroughfares are easier to remember and are not confusingly similar to the name of other public roads within the City.

**NOW THEREFORE**, upon unanimous motion of the Sangguniang Panlungsod, in regular session duly assembled, **BE IT RESOLVED AS IT HEREBY RESOLVED** to express the wholehearted support of the city council to the approval of House Bill No. 4189 renaming of Molino Boulevard situated within the City of Bacoor into "Bacoor Boulevard" and to the approval of House Bill No. 4190 renaming the Molino-Salawag-Paliparan Road which extends from the City of Bacoor to the adjoining City of Dasmariñas into the "Bacoor-Dasmariñas Road".

**RESOLVED FURTHER**, to furnish the office of Congressman Revilla and all other government agencies concerned with copies of this Resolution.






