A RESOLUTION AUTHORIZING THE CITY MAYOR TO ENTER, EXECUTE, AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) FOR THE PERFORMANCE CHALLENGE FUND (PCF) SUBSIDY AND IMPLEMENTATION OF THE PCF PROJECTS.

**WHEREAS**, the City of Bacoor was awarded the 2016 Seal of Good Local Governance (SGLG): "Pagkilala sa Katapatan at Kahusayan ng Pamahalaang Lokal" by the Department of the Interior and Local Government (DILG) based on the assessment of the performance of the city government for Calendar Year 2015.

**WHEREAS**, the City Government of Bacoor is entitled to receive Three Million Four Hundred Thousand Pesos (PhP 3,400,000.00) from the Performance Challenge Fund (PCF) by reason of the said recognition to improve its performance and service delivery.

**WHEREAS**, one of the requisites for the release of the said amount from the PCF is the signing by the City Mayor of the corresponding Memorandum of Agreement (MOA) with the DILG that contains provisions on the duties and responsibilities of the city government relating to the allocation and use of such funds which shall be under the monitoring of the DILG pursuant to Memorandum Circular No. 2016-153 issued on 28 October 2016.

**NOW, THEREFORE**, upon unanimous motion of all the councilors present, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod duly assembled in regular session to authorize the City Mayor, Hon. Lani Mercado-Revilla, to enter, execute, and sign a Memorandum of Agreement (MOA) with the Department of the Interior and Local Government (DILG) for the Performance Challenge Fund (PCF) subsidy and for the implementation of the PCF projects in a manner consistent with law.
