A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN A MEMORANDUM OF UNDERSTANDING WITH THE PHILIPPINE RECLAMATION AUTHORITY (PRA) REGARDING THE PROPOSED RECLAMATION AND LAND DEVELOPMENT BY THE LOCAL GOVERNMENT OF THE CITY OF BACOR OF AN AREA OF 900 HECTARES, MORE OR LESS, SITUATED WITHIN THE MUNICIPAL WATERS OF THE CITY OF BACOR.

WHEREAS, the local government of the City of Bacoor intends to reclaim an area consisting of 900 hectares, more or less, within the municipal waters of the city for future development as a commercial, industrial, residential, and tourism center.

WHEREAS, in order to make the proposed land reclamation project mentioned above possible, the city government, through Mayor Lani Mercado-Revilla, informed the Philippine Reclamation Authority (PRA) in writing of its intention to reclaim the said area.

WHEREAS, in response to the said letter, the PRA sent a draft Memorandum of Understanding (MOU) between the City of Bacoor and the PRA the terms and conditions of which are intended to guide the city government in the submission of the various documentary requirements for the conduct of such a reclamation project within the period and in accordance with the process mandated under Section 7 of the NEDA-PRA Joint Order No. 01-2015.

WHEREAS, the Sangguniang Panlungsod reviewed the said MOU and its members unanimously concluded that the terms and conditions of the said legal document shall redound to the best interest of the city government and that of the residents of the City of Bacoor.


