



A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT WITH THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS (NCCA) REGARDING THE GRANT BY THE LATTER OF PHP 500,000.00 TO THE CITY GOVERNMENT PURSUANT TO THE HOLDING OF THE "PAMBANSANG SERENATA NG MGA BANDA SA PILIPINAS" PROJECT.

WHEREAS, the Office of the City Administrator submitted a draft Memorandum of Agreement (MOA) between the city government and the National Commission for Culture and the Arts (NCCA) for review and consideration by the Sangguniang Panlungsod.

WHEREAS, under the terms and conditions of the said MOA, the NCCA shall grant financial assistance to the city government amounting to PhP 500,000.00 pursuant to the holding of the "Pambansang Serenata ng mga Banda sa Pilipinas" project of the said national agency.

WHEREAS, the Sangguniang Panlungsod reviewed the said MOA and its members unanimously concluded that the terms and conditions of the said legal document shall redound to the best interest of the city government and that of the residents of the City of Bacoor.

NOW THEREFORE, upon joint and unanimous motion of the Body, in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize the City Mayor, Hon. Lani Mercado-Revilla, to sign the Memorandum of Agreement between the City of Bacoor and the National Commission for Culture and the Arts (NCCA) with regard the grant financial assistance to the city government amounting to PhP 500,000.00 pursuant to the holding of the "Pambansang Serenata ng mga Banda sa Pilipinas" project of the said national agency.


