A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN A SISTER CITY AGREEMENT WITH THE CITY OF MANILA FOR AND ON BEHALF OF THE CITY OF BACOR, CAVITE.

WHEREAS, in a letter dated 15 August 2016, Mayor Lani Mercado-Revilla proposed the forging of a "Sister City Agreement" between the City of Bacoor and the City of Manila to Mayor Joseph E. Estrada of Manila to facilitate the hosting by the City of Bacoor of the International Marching Band Competition in 2017.

WHEREAS, in reaction to the said proposal, the City Council of the City of Manila passed Resolution No. 333-S-2016 on 27 October 2016, endorsing the establishment of a "Sisterhood Agreement" between the cities mentioned above to Mayor Estrada.

WHEREAS, a copy Resolution No. 333-S-2016 was sent by the Office of the City Administrator to the Sangguniang Panlungsod together with a request for the approval of a resolution authorizing Mayor Mercado-Revilla to sign a "sisterhood pact" between the aforementioned local government units.

WHEREAS, the members of the Sangguniang Panlungsod unanimously concluded that the City of Bacoor shall be greatly benefited by becoming the sister city of the City of Manila in the fields of tourism, traffic management, and environmental protection and in other possible areas of cooperation.

NOW THEREFORE, upon joint and unanimous motion of the Body, in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize the City Mayor, Hon. Lani Mercado-Revilla, to sign the proposed "Sister City Agreement" between the City of Bacoor and the City of Manila.

RESOLVED FURTHER, to furnish the Office of the Mayor of the City of Manila and other government offices concerned with copies of this Resolution.




