A RESOLUTION SUPPORTING AND FAVORABLY ENDORSING THE VARIOUS DEVELOPMENT PROJECTS BEING COLLECTIVELY PROPOSED BY CONGRESSMAN STRIKE B. REVILLA, MAYOR LANI MERCADO-REVILLA, THE SANGGUNIANG PANLUNGSOD AND THE LOCAL DEVELOPMENT COUNCIL TO THE SANGGUNIANG PANLALAWIGAN OF THE PROVINCE OF CAVITE, TO THE REGIONAL DEVELOPMENT COUNCIL, AND TO THE NATIONAL ECONOMIC DEVELOPMENT AUTHORITY FOR INCLUSION IN THE PHILIPPINE DEVELOPMENT PLAN 2017-2022.
