A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOOD WITH MEADOWOOD EXECUTIVE VILLAGE HOMEOWNERS' ASSOCIATION, INC. (MEVHIA) SIGNIFYING THE CONSENT OF THE LATTER TO INCLUDE THE VARIOUS ROADS WITHIN MEADOWOOD EXECUTIVE VILLAGE SUBDIVISION IN THE "SOLIDARITY ROUTE" PROGRAM AND ITS IMPLEMENTING RULES AND REGULATIONS.

WHEREAS, the then Sangguniang Bayan unanimously enacted Municipal Ordinance No. 21-S-2009 on 9 November 2009 entitled: "An Ordinance Creating A Traffic Decongestion Scheme to be Known as the "Solidarity Route" In The Municipality of Bacoor, Cavite" as amended on 7 October 2013 by City Ordinance No. 2013-047 otherwise known as "The Revised Traffic Code of the City of Bacoor".

WHEREAS, the said ordinances authorized the use of certain private roads within residential subdivisions by motor vehicles that bear "Solidarity Route" stickers in order to decongest vehicular traffic in major thoroughfares within the City of Bacoor, Cavite.

WHEREAS, the road lots owned by Sta. Lucia Realty Development Corporation in Meadowood Executive Village Subdivision located in the City of Bacoor, Cavite will form part of the "Solidarity Route" project of the city government. The following roads within the said subdivision shall form part of the Solidarity Route pursuant to City Ordinance No. 2013-047, to wit:

" Bacoor Boulevard to Aguinaldo Highway:

a) From Bacoor Boulevard passing thru Niog Road, turning left to Meadowood Village Gate 2 - Meadowood Avenue exit Gate 1, then to Aguinaldo Highway (across SM Bacoor). "




