A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT FOR AND ON BEHALF OF THE CITY OF BACOR WITH THE PARAÑAQUE ULTRASOUND AND DIAGNOSTIC CENTER INC. PURSUANT TO THE PUBLIC HEALTH PROGRAM OF THE CITY GOVERNMENT SUBJECT TO CERTAIN CONDITIONS.

WHEREAS, the local government of the City of Bacoor is mandated under Section 16 of Republic Act No. 7160 to undertake such plans and programs that would promote the general welfare.

WHEREAS, the promotion of public health is an essential component of the above-mentioned mandate. Consequently, the city government had been providing free or subsidized medical and health services at the various health and lying-in centers within the City of Bacoor.

WHEREAS, the City Administrator wrote the Sangguniang Panglungsod and requested the Body to pass a resolution authorizing the City Mayor to sign a Memorandum of Agreement with Parañaque Ultrasound and Diagnostic Center Inc. for and on behalf the city government pursuant to the latter's public health program.

WHEREAS, a review of the said MOA conducted by the Body revealed that its terms and conditions are in accord with the public health program of the city government. However, the fees to be charged against the public that avails of the various laboratory services enumerated in the proposed MOA does not seem to coincide with the various fees provided under Chapter 3, Section 18 of City Ordinance No. 55-2015 (otherwise known as the "Bacoor City Health, Sanitation and Public Health Code").
