**A RESOLUTION RESPECTFULLY REQUESTING THE MANILA ELECTRIC COMPANY TO FORMULATE A PROGRAM AKIN TO THE "PEAK-OFF-PEAK PROGRAM" OF THE SAID PUBLIC UTILITY FOR THE BENEFIT OF THE VARIOUS BARANGAYS WITHIN THE CITY OF BACOR.**

**WHEREAS**, Section 16 of Republic Act No. 7160 (the "Local Government Code of 1991") provides that "every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare" and such measures as may be needed to "maintain peace and order, and preserve the comfort and convenience of their inhabitants".

**WHEREAS**, the City of Bacoor has 73 barangays. Each of the said barangay conduct business through its barangay hall. The said barangay halls are open 24/7 so that they may best serve the interests of the residents of the said barangays and, in so doing, promote the general welfare.

**WHEREAS**, most of the said barangay halls serve as command centers where rescue and relief operations are conducted during natural calamities.

**WHEREAS**, the Meralco recently offered to extend the coverage of the city government in the said public utility's "Peak-Off-Peak Program" which is designed to significantly reduce the electric consumption of the city government in the operation of the various streetlights located on various public roads.

**WHEREAS**, all of the said barangays operate streetlights located on barangay roads that are not covered by the "Peak-Off-Peak Program" of the Meralco.

**WHEREAS**, given the importance of the barangays in the promotion of the general welfare and the limited budgets of the same - the Sangguniang Panlungsod would like to
