A RESOLUTION AUTHORIZING THE CITY MAYOR TO: (1) PAY THE AMOUNT OF PHP 1,057,280.00 TO THE PHILIPPINE RECLAMATION AUTHORITY (PRA), (2) PROCURE THE SERVICES OF A CONSULTANT WHO SHALL ASSIST THE CITY GOVERNMENT IN SECURING VARIOUS COMPLIANCE REQUIREMENTS PURSUANT TO THE RELEVANT PROVISIONS OF LAW, (3) EXECUTE AND FILE WITH THE PRA SUCH DOCUMENTS AND OTHER REQUIREMENTS PURSUANT TO THE MEMORANDUM OF UNDERSTANDING DATED 07 DECEMBER 2016 BETWEEN THE CITY GOVERNMENT AND PRA, AND (4) PAY THE ADDITIONAL AMOUNT OF PHP 2,114,560.00 TO THE PRA AS PROCESSING FEE ALL IN RELATION TO THE PROPOSED BACoor BAY RECLAMATION PROJECT.

WHEREAS, on 3 January 2017, the Sangguniang Panlungsod received a letter from the Acting City Administrator, Mr. Jerome V. Oliveros, requesting the city council to pass a resolution in relation to the Memorandum of Understanding (MOU) between the city government and the Philippine Reclamation Authority (PRA) dated 7 December 2016 involving the proposed 944-hectare Bacoor Bay Reclamation Project.

WHEREAS, the said resolution, as per the request of Mr. Oliveros, should authorize the City Mayor to: (a) pay a filing fee of PhP 1,057,280.00 to the PRA pursuant to the provisions of the said MOU, (b) procure the services of a consultant who shall assist the city government in securing the various compliance requirements under the said MOU, (c) execute and file with the PRA the various compliance requirements mentioned above, and (d) pay a processing fee of PhP 2,114,560.00 to the PRA also in accordance with the said MOU.

WHEREAS, a review by the Sangguniang Panlungsod of the said letter request and of the pertinent provisions of the afore-mentioned MOU revealed that the authority being requested are all in accordance with law and are not disadvantageous to the government.
