A RESOLUTION DECLARING A MORATORIUM IN THE CONSTRUCTION OF WAREHOUSES ALL OVER THE CITY OF BACoor WHILE THE CITY GOVERNMENT REVIEWS THE IMPACT OF THE VARIOUS TRUCKS USING THE SAID BUSINESS ESTABLISHMENTS ON THE FLOW OF VEHICULAR TRAFFIC ON VARIOUS PUBLIC ROADS IN THE CITY.

WHEREAS, the Sangguniang Panlungsod received on 17 October 2016 a written request from the Bacoor Association of Professionals and Businessmen Incorporated (BAPBI) for the suspension of the "Truck Ban" embodied in Sections 85 and 85.1 of City Ordinance No. 2013-47 (otherwise known as the "Revised Traffic Code of the City of Bacoor") due to the alleged deleterious effect of the said motor vehicle volume reduction scheme on local businesses.

WHEREAS, the said request prompted the Sangguniang Panlungsod to conduct a public hearing attended by operators of various businesses and by representatives of the BAPBI some of whom own or operate trucks in the conduct of their respective businesses.

WHEREAS, the Bacoor Traffic Management Department (BTMD) reported to the Office of the City Mayor that one of the reasons behind the worsening traffic situation on various public roads is the increase in the number of warehouses constructed within the city during the last three years. It was also reported that the said warehouses are being used as garages by various trucks, the drivers of which use public roads in making various turning maneuvers in order to park their driven vehicles resulting in traffic congestion.

WHEREAS, due to the said findings, the Office of the City Mayor requested the Sangguniang Panlungsod to pass a resolution temporarily declaring a moratorium in the grant of building permits and zoning permits related to the construction of new warehouses within the City of Bacoor while the BTMD conducts an in-depth study on the effect of the said business establishments on motor vehicle flow on various public roads within the city.
